I. **THE PARTIES.** This is an agreement to sublet real property ("Sublease") entered into on _____, 20____, by and between:

II. **TERM.** Tenancy of this Sublease shall begin with the Sublessee taking possession on _____, 20____ and ending on the _____, 20____. Under no circumstances shall there be holdover by the Sublessee.

III. **RENT.** The Sublessee agrees to pay rent under this Sublease in the amount of \$_____ payable on the _____ of each Month to the Sublessor. The rent shall be paid in the following manner: _____.

IV. **SECURITY DEPOSIT.** The Sublessor shall require a Security Deposit in the amount of \$_____ that will be paid at the beginning of the term ("Security Deposit") by the Sublessee. Any reason for retaining a portion of the Security Deposit shall be explained in writing when returning the funds to the Sublessee. 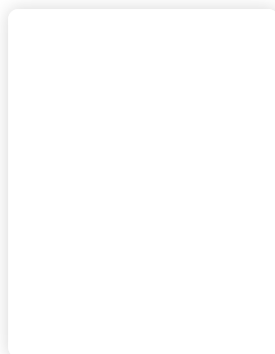
CREATE DOCUMENT

A **Maryland sublease agreement** establishes a rental relationship between a tenant in a rental property and a third-party tenant not listed in the primary lease agreement. The landlord's permission is almost always necessary for this kind of tenancy. The subtenant in a sublease is not liable to the landlord of the property. They are liable to the primary tenant. All potential subtenants should complete a [rental application](#) so the primary tenant can check their background.

Landlord's Consent Form – Use this form to confirm a landlord approves of a subletting agreement, particularly when the primary lease forbids subletting.

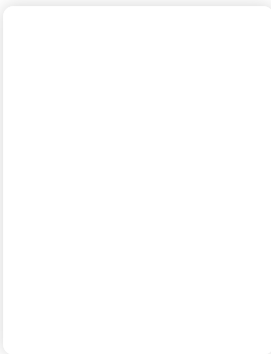
